<b>Network Change Summary:</b>			
Cincinnati Bell Telephone Company plans to decommission the Unit 2 5ESS switch (CNCNOHWSDS2) located at its 209 West Seventh Street serving wire center. All traffic will be migrated to the Unit 1 5ESS switch (CNCNOHWSDS1) also located at the 209 West Seventh street serving wire center. All carrier circuits on this switch must be migrated to an alternative switch.			
<b>Description of type of changes planned:</b>			
The Unit 2 5ESS switch (CNCNOHWSDS2) located at Cincinnati Bell Telephone Company's 209 West Seventh Street serving wire center will be decommissioned. As a result, all circuits terminated on the 209 West Seventh Street Unit 2 5ESS switch must be moved to the 209 West Seventh Street Unit 1 5ESS switch (CNCNOHWSDS1). Impacted carriers must issue ASRs to Cincinnati Bell Telephone Company to migrate their circuits to the Unit 1 switch.			
<b>Description of Reasonably Foreseeable Impact of the Planned Changes:</b>			
All services currently provisioned on the Unit 2 5ESS switch (CNCNOHWSDS2) will be migrated to Cincinnati Bell's Unit 1 5ESS switch (CNCNOHWSDS1) at 209 West			

Seventh Street. All carriers (CLECs, IXCs, wireless, etc.) that currently have circuits terminating on the Unit 2 5ESS switch should migrate them to Cincinnati Bell's Unit 1 switch (CNCNOHWSDS1) no later than 9/13/2017. Impacted carriers must issue ASRs to Cincinnati Bell Telephone to migrate their circuits to the Unit 1 switch.
